CANCELLATIONS

- If an instructor is on leave, client will be handed over to another instructor for that period or instructor will make up classes missed during that time
- If client goes away, they will be charged the full rate for that timeslot. You may make your session up before or after your trip.
- If, for any reason instructor cancels appointment with less than a 24-hour notice, session will be made at the next available time suitable for both parties.
- Rescheduled Classes cannot be made up, if clients cancel they forfeit their session.
- 24-hour notification is required to reschedule class otherwise client forfeits the session.
- Should you not arrive for a class for whatever reason, a full session rate will be charged.
- 1-month notice period to cancel contracts.
 - **Notice of withdrawal may NOT be given in November for December.**
- Clients pay to keep their slots regardless of if they attend, if you discontinue your sessions, your times /slots can be given away.
